Visual observation techniques were employed to verify compliance with project drawings/specifications, applicable codes and material submittals.

The following observations were observed on the site this day:

- The placement and compaction of backfill for the construction entrance was in progress using CP54B, RA30, D51PX and CAT330 equipment.
- The placement and compaction of backfill for Lots #66 to 73 was in progress using CP54B, RA30, D51PX and CAT330 equipment.
- Placement and installation of box culverts at the outlet area of the permanent detention pond was in progress.
- At the time of arrival our representative observed that the work was in progress at the construction entrance and Lots #66 to 73 with 1-foot lifts being placed and compacted using CP54B and D51PX equipment.
